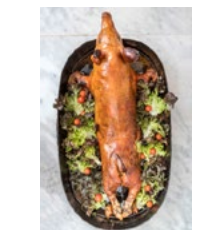

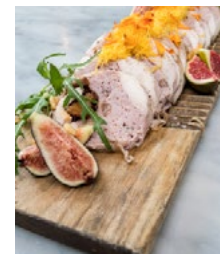
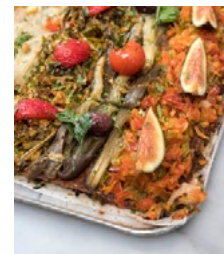

BOOKING CONDITIONS AND CANCELLATION POLICY

VAT included, subject to legislative modifications when required.

Live&Sea will invoice agencies directly at invoice price. We do not accept in any case, compensation invoices for commission.

The prices applicable to catamaran transport include the crew required for the development of the activity.

Drinks and catering services are EXCLUSIVE to LIFE&SEA, no external contracting is allowed.

Extra crew (to improve the service) 200€ without commission and VAT included.

If embarkation takes place in a place other than Arenal, a supplement will be added.

Booking conditions

In order to confirm reservations, 50% of the total amount of the invoice corresponding to the transport must be paid, the remaining 50% must be paid a maximum of 7 days before embarkation.

The total amount for catering and beverages must be paid at the latest 15 days before boarding.

In the event of adverse weather conditions, and the captain of the boat will decide, the excursions will be cancelled and LIFE&SEA will refund the total amount of the invoice corresponding to the transport. However, the contracted meal service will not be refunded in order for the client to enjoy it in another establishment provided by the client.

Cancellation policy

The costs incurred by the cancellation of the activities as a participant will be charged to the client:

Cancellations with prior notice between 30 and 15 days: loss of 50% of the amount of the catamaran booking.

Cancellations with prior notice of less than 15 days: total loss of the amount of the catamaran booking.

Catering: if the cancellation is made before 15 days, the invoice will be paid at no charge for the client.

If the cancellation is made within 15 days prior to departure, the client will lose the total amount paid for catering.

If the excursion is not attended on the date of the excursion: no refunds will be made.
